

Should you opt out of Direct Compensation Property?

Should you opt out of Direct Compensation Property Damage coverage? Soon, Ontario drivers will have a new option to restrict coverage in the event of a collision—the option not to claim damages.

In December 2022, the Financial Services Regulatory Authority of Ontario (FSRA) announced that Ontario Policy Change Form (OPCF) 49 will give drivers the choice to opt out of Direct Compensation Property Damage (DCPD) coverage.

Now, that's a lot of acronyms! Essentially, what that means is that in the event of a collision where you aren't at fault, you can choose not to be compensated for costs, including:

The cost to repair or replace your vehicle

The loss of use of the vehicle (e.g. a rental vehicle or taxi services while your vehicle is inoperable)

Loss or damage to the vehicle's contents

Towing and storage fees

OPCF 49, formally known as the Agreement Not to Recover Loss or Damage from an Automobile Collision, was introduced "to enable innovation and choice," as stated in the provincial announcement.1

Under OPCF 49, you can agree not to be compensated by your insurance company or anyone else, including anyone at fault for causing the damage or their insurance company. But what does that mean?

What is Direct Compensation Property Damage?

DCPD coverage falls under Ontario's Insurance Act, passed in 1990. All Ontario drivers are covered under this mandatory coverage for their benefit. If you're involved in a not-at-fault or partially-at-fault collision, DCPD ensurthat you will be compensated by your insurer.

However, DCPD coverage requires that one or more vehicles were involved in the collision, the vehicle (and its contents) that suffers damage is insured in Ontario, and at least one other vehicle involved in the collision is insured in Ontario.

Different from DCPD coverage, collision coverage is an optional add-on that pro-

vides coverage in the event that you're involved in an at-fault collision.

Why would someone opt out of DCPD? As previously mentioned, the ability to opt out of DCPD (or opt into the OPCF 49) was introduced to provide drivers with coverage flexibility and cost savings. If you opt out of this coverage, you could save on your annual premium, but the savings is minimal. Be that as it may, there are not many candidates and scenarios to which this option is recommended. So, while it may be tempting for Ontarians desperate to save money on their auto policy to sign away their DCPD coverage, the financial risks outweigh any short-term cost savings.

Should you opt out of DCPD? OPCF 49 states that "Even though you are not at fault, your insurance will not cover this or help you with the loss. You must arrange for your repairs and rental vehicle, all at your own effort and expense."

If you opt out of this coverage, you agree not to recover loss or damage, meaning you're on the hook without any recourse if you're in an accident. Especially if you lease or finance your vehicle, you shouldn't sign the form without consulting your lease or financing company as most contracts require physical damage coverage to be in place.

Extended vehicle repair times may also considerably impact the loss of use of your vehicle. Since global supply chains are



trying to recover from the COVID-19 pandemic, repairs that might have taken a few days to complete are still taking double the time.

For those reasons and peace of mind, it's best to keep your DCPD coverage as it is.

What it's all about By signing the OPCF 49, you cannot claim DCPD, Collision, or Upset coverage. You may reinstate this protection at any time and pay the premium adjustment, but until then, your insurance won't cover the damage or help you with the loss. It's noteworthy that in the event of a collision, you cannot reinstate your protection to cover pre-existing damage.

Effective January 1, 2024, insurers will be required to offer consumers the OPCF 49. However, rather than signing away this vital coverage, there are alternative saving opportunities that your insurance representative can help you explore, like changing your deductible, bundling your policies, or installing a telematics device.

RTIP RENEWAL

If you have health and/or dental insurance with RTIP, you would have received (by email or in the mail) your renewal which was sent out about November 30/2023. (Check your SPAM Folder). You have until January 31, 2024, to change your plan. Your health circumstances may also have changed.

If you have turned 65, you may find that the ODB (Ontario Drug Plan) covers your drugs. (check with your pharmacist). If this is the case, you may want to change from the \$4000/\$2500/\$750 plan going up or down.

Did you retire after June 2019?

OSSTF is currently negotiating the resolution of the Bill 124 arbitration (the current government legislated a 1% pay – which was deemed unconstitu-

tional by the courts). This means that you may be eligible for back pay. The School Board will be assigned the task of sending out this money. Make sure that they have updated contact information for you (ex. New address, email, phone number).

Home Care Survey

ARM Chapters and some Districts across the province are being asked to complete a Home Care Survey. The survey data will be compiled and used to advocate for better support services

for Home Care in Ontario. If you have registered for electronic newsletters, you will receive the link to the survey on or near January 31, 2024, for completion by February 14, 2024. Others may access the survey on our website, from January 31, 2024, to February 14, 2024.

Obey the Speed Limit

The State Police officer, trying to contain a chuckle explains to her that "22" was the route number, not the speed limit. A bit embarrassed, the woman grinned and thanked the officer for pointing out her error. "But before I let you go, Ma'am, I have to ask, is everyone in this car OK? These women seem awfully shaken and they haven't muttered a single peep this whole time," the officer asks. "Oh, thev'll be all right in a minute officer. We just got off Route 142."



When should older drivers have to stop driving?

Professional driving evaluator shares warning signs and safety tips By Melissa Rudy Fox News

Young drivers must be a certain age to get a license — but it is less clear when older adults should hang up the keys.

Between 2020 and 2021, the number of motor vehicle deaths involving adults 65 and older rose by 15%, exceeding 8,200 fatalities, according to data from the National Safety Council.

Fox News Digital spoke to Tina Paff, president of Bick's Driving School of Western Hills in Ohio, about how to ensure the safety of aging drivers — and how family members can recognize the potential warning signs. Red flags for senior driving

Red flags for senior driving

Paff heads up the Bick's Driver Rehabilitation Program, which evaluates older adults' driving skills to determine whether to recommend they "retire" from operating vehicles.

For family members and loved ones who are concerned about the risks of older adults driving, Paff identified several warning signs.

Physical damage to vehicles. A key red flag is if the driver starts to get into minor accidents, which could indicate negligence behind the wheel.

"It might not be their fault, but it also could be because of the way they were performing on the road," Paff said.

She recommended inspecting the outside of the senior's car for signs of damage, such as dents and scratches on the bumpers. Another telltale sign is damage to the mirrors; this could indicate that the driver is tapping mailboxes or hitting curbs.

Effects of medication. It's important for family members to understand the potential effects of any medications the driver is taking, Paff noted.

"Starting a new medication or

changing dosages can potentially change some of a person's habits, including driving," she said.

Slower driving. As adults age, they tend to start slowing down on the road, the expert said.

"Sometimes an older adult is going to feel like their driving is safer because they've slowed down, but it's actually causing more problems," she noted.

Vision changes. As older adults' vision becomes challenged, it's essential that they see an eye doctor to get evaluated for glasses or corrective procedures, said Paff.

"In cases of macular degeneration, they could start having some blind spots in their vision and not see a car or a person," she warned.

Mild cognitive impairment. The Driver Rehabilitation Program often works with physicians to determine recommendations for older drivers' abilities.

"'Mild cognitive impairment' is a very generalized term that we hear a lot from doctors," Paff said.

If an older adult is starting to experience early signs of dementia or Alzheimer's, it can show in their driving skills.

"One of the biggest signs that we see with cognitive impairment is what we call processing speed," Paff said

"Even though the adult will know how to make a left turn in traffic and yield, they may be delayed in doing it."

Additionally, if an older adult starts shuffling or walking extremely slowly, the family might chalk it up to a regular effect of aging, Paff said — but that could also delay their reaction time when driving.

Evaluations and modifications

When it comes to determining whether a senior should continue driving, it's not always a clear-cut "yes or no" decision.

In many cases, Paff said, families or doctors' offices will contact Bick's to request a safety evaluation for a senior driver.

Adult children often say they aren't comfortable riding in the car with an aging parent.

"If you're scared, then something is wrong," Paff said. "And that's where we come in with the evaluation, because the kids don't want to be 'the bad guy' and take away a parent's driver's license."

During a two-hour assessment, Bick's gauges the driver's vision skills, physical skills and cognitive skills, then takes them on a driver's test.

Sometimes modifications can be put into place to ensure a safer driving experience.

"There are often things we can do to help them continue driving that a son or daughter wouldn't think of," Paff said.

As people get older and experience spinal changes, for example, they might not be able to turn their necks as fully as they once could.

"We might recommend different styles of mirrors that can be applied to the car that show all the blind spots for people with limited mobility," Paff said.

There may also be an opportunity to modify seating to meet older drivers' needs.

Even when driving the same car they've operated for years, they may not be able to see properly due to shrinkage, Paff noted.

"In that case, it may just be a matter of using seat cushions," she said.






